Therefore these measures should not be viewed in isolation but considered together with the Consolidated Financial Information (unaudited) prepared in accordance with U.S. GAAP as of and for three months ended March 31, 2022, and with the Consolidated Financial Statements prepared in accordance with U.S. GAAP as of and for the years ended December 31, 2021, 2020, 2019 and 2018.

Operational EBITA Margin

Operational EBITA margin is Operational EBITA as a percentage of operational revenues.
